The ranks of the United States Air Force are divided among enlisted qualifications, such as officials and sergeants and officers, as lieutenant, captain, colonel, and general. Officers represent Air Force leaders and managers. If you want to be an Air Force pilot, you must first be a commissioned officer. There are three different ways to win a commission and fix the gold bars as a new second Lieutenant of the Air Force. The Air Force requires that all new officers have earned a four-year college degree. The good news is that if you are still in high school or have just started college, the Air Force will pay the costs of that required college education. If you already have a degree or are close to graduation, you can become an officer in a short period of time. The best way to get an officer's commission often depends on your current level of education and where you want to go from here. The U.S. Air Force Academy offers a combination of college degree and military training so graduates can be immediately commissioned as Air Force officers. Everyone who graduates from the Academy becomes military officers. To enter the Air Force Academy, you must be nominated by your U.S. representative or a senator from your state. The offices of these elected officials can assist you during the application process. It is also possible to attend the U.S. Military Academy at West Point or the U.S. Naval Academy in Annapolis and choose to become an Air Force officer when you graduate. The Air Force Reserve Officer Training Corps is a scholarship program in which the Air Force will pay for a college degree. Then you become an Air Force officer after you graduate. The Air Force ROTC is the largest source of new Air Force officers. ROTC programs are available at more than 1,000 universities and colleges. You can enroll in ROTC before or during college. Enlisted Air Force members can also use the program to earn a degree and become officers. An online application is available on the Air Force ROTC website to get started. If you already have a degree, the Air Force will make you an officer in nine weeks at the Service Officer Training School. You can go to training school by enlisting in the Air Force with an agreement that will attend officer school. An enlisted current member can also take the OTS route to become an officer who gets a degree while at work. Most people have a general idea that the president's plane is a flight office with all kinds of high-tech equipment. But two essential facts about Air Force One that the general public does not know about. Air Force One is not technically an aircraft: it is simply the name of the radio call for any U.S. Air Force aircraft that takes the president of the United States. As soon as the president boards an Air Force aircraft, that aircraft is referred to as Air Force One by crew and all air traffic controllers, in order to avoid confusion with any other aircraft in the area. If the president rides in an army army that the plane is Army One, and every time you board your specialized helicopter, that ship is Marine One. Civilians generally refer to the physical aircraft itself as the Air Force One, of course, and we will do so in this article as well. Today, there are actually two aircraft flying regularly under this designation: nearly identical Boeing 747-200B aircraft. The aircraft are designated VC-25A, with queue numbers 28000 and 29000. The two aircraft have the same overall structure as a normal Boeing 747-200B, and similar capabilities. They are almost as tall as a six-story building, and are as long as a city block. Each has four General Electric CF6-80C2B1 jet engines, providing 56,700 pounds of thrust per piece. Air Force One, the plane carrying the president of the United States, cost about \$2 billion to build and more than \$200,000 to fly, according to federal expense records and published reports. Taxpayers pay for part or all of the cost of Air Force One regardless of whether the president's plane is used for official travel or unofficial political purposes. The two new Air Force One aircraft, both 747-8 models, are being equipped by Boeing at a combined cost of about \$3.9 billion and were to fly in 2021. The White House determines whether the use of Air Force One is for official or political purposes. The Boeing 747 is often used for a combination of events. Air Force One's hourly cost covers everything from fuel, maintenance, engineering support, food and accommodation to pilots and crew, and other operating costs including the use of special communications equipment. In addition to the hourly cost of Air Force One, taxpayers cover salaries from Secret Service staff and other attendees traveling with the president. Occasionally, when more than 75 people are traveling with the president, the federal government will use a second passenger plane to accommodate them. Perhaps the most common example of official use of the Air Force by the president is to travel across the United States to explain and gain support for his administration's policies. Another is traveling abroad for official state businesses to meet with leaders like President Barack Obama's 2010 air force trip to India. When a president travels on official business, taxpayers cover all Air Force One costs, including food, lodging, and car rental, according to the During official travel, taxpayers also cover the cost of travel for the president's family and immediate staff. The most common example of a political journey on Air Force One is when the president travels to a destination in his role not as commander-in-chief, but as a de facto leader of his political party. Such a trip would be to attend fundraisers, campaign rallies or party events. Along the way, Obama and other presidential candidates have also come to use armored buses that cost more than \$1 million each. When Air Force One is used for political purposes, the president often reimburses the government for the cost of food, accommodation and travel. The president or his election campaign returns an amount that is equivalent to the airfare they would have paid if they had used a commercial airline, according to the Congressional Investigative Service. According to The Associated Press, however, the president or his campaign does not pay for the full cost of Air Force One operation. They pay an amount that is based on the number of people boarding the plane. Taxpayers still collect the cost of Secret Service agents and air force one operation. The president and his family and staff travel on Air Force One for a combination of political and official purposes, usually reimbursing taxpayers for the part of the trip that is considered a campaign. For example, if half of the president's trip is spent raising money for his election or another official, he or his campaign will reimburse taxpayers for half the cost of their trip, food, and accommodation. There are gray areas, of course. When traveling and appearing in public to defend their political positions, the difference between their official duties and their activities as leaders of their political party can be difficult to assess, congressional Research Service says. As a result, the White House decides the nature of travel on a case-by-case basis, trying to determine whether or not each trip is official when considering the nature of the event involved, and the role of the individual involved. Air Force One has 4,000 square feet of interior floor space. Much of it looks more like a hotel or executive office than a jetliner, except for the seat belts of all the chairs.
